



Pediatric Clinical Neuropsychologist Position

Learning & Emotional Assessment Program (LEAP) Department of Psychiatry

We are pleased to announce immediate openings for full-time pediatric clinical neuropsychologists at the Learning and Emotional Assessment Program (LEAP) within the Department of Psychiatry of Massachusetts General Hospital (MGH) in Boston, MA.

LEAP specializes in the assessment of children and adolescents ages 2-22, emphasizing a collaborative and holistic approach that engages the child, family, and referring provider. Patients are referred from pediatricians, child psychiatrists and psychologists, child neurologists, and other medical specialties (e.g., genetics, endocrinology, etc.) throughout the MGH system. Our services include consultation, brief and full evaluations that integrate telehealth practices.

Experience and training assessing the impact of varied medical conditions on brain development is required. Experience assessing very young children, those with significant developmental delays, and/or those with comorbid autism spectrum or psychiatric disorders is preferred, along with experience working with medical interpreters. The neuropsychologist will play a significant role in training, including supervision and teaching of psychology interns and neuropsychology postdoctoral fellows.

While clinical care and training will be the primary responsibilities, LEAP has a well-developed and integrated clinical research program. All clinical faculty can collaborate on research projects and/or can pursue independent research opportunities.

The position offers a competitive salary and generous benefits. In addition to a staff appointment at MGH, there will be an academic appointment at Harvard Medical School (HMS) at the Instructor, Assistant Professor or Associate Professor level, to be determined based on experience.

Candidates should be board-certified or eligible for ABPP board certification in clinical neuropsychology and subspecialty certification in pediatric neuropsychology. Candidates must have completed a doctoral degree in clinical or school psychology from an APA/CPA accredited program and an APA/CPA accredited pre-doctoral internship. Prior to the start date, the candidate must have also completed a formal two-year postdoctoral fellowship or equivalent in pediatric or developmental neuropsychology and be licensed in the State of Massachusetts. Training and experience must also meet MGH Psychiatry criteria for credentialing as a pediatric psychologist specializing in assessment.
