Alvin Powell, MD

Join us on Dec. 2nd to pay tribute to the [1619 Project](#), a major initiative by *The New York Times* to observe the 400th anniversary of the beginning of American slavery. We have invited Dr. Alvin Powell, the Chief Health Equity Officer of Cone Health from Greensboro NC. On Nov 1st, 2016, to celebrate the 53rd anniversary of the 1963 landmark [Simkins v. Cone Hospital lawsuit](#) that desegregated hospitals, a historical marker was placed beside Moses H. Cone Memorial Hospital by a local medical society. Cone Hospital CEO apologized to the community and the sole living plaintiff Dr. Alvin Blount, 94, for the hospital’s past role in perpetuating discriminatory practices in healthcare.

Dr. Powell is a native of Boston, who received his undergraduate education at Columbia University, medical degree from Tufts University School of medicine, completed his residency training in Internal medicine at Duke University and a fellowship in nephrology at Emory University. He has been a nephrologist in private practice in Greensboro for 29 years and was the former President of medical staff at Cone Hospital. He was previously employed by the National Health Service Corps at a community health center in Florida and has been a volunteer in medical missions in Haiti and Honduras. As a child he received his medical at Boston City Hospital and Dimock Community Health Center.

3. MGH/Timilty partnership: The MGH Center for Community Health Improvement's Youth Programs team is seeking volunteers to mentor select students from


