

MGH Translational Clinical Research Fellowship at Pfizer

The Pfizer Innovation Research Laboratory (PfIRe Lab) fellowship is an opportunity for a physician scientist to gain firsthand experience in the pharmaceutical industry. The PfIRe Lab is a state-of-the-art research facility in Cambridge, Massachusetts and has a unique role within Pfizer Inc to transform clinical development in drug trials. Over the last few years PfIRe Lab studies have utilized mobile/digital technologies capable of continuous monitoring of patient physiology to develop novel endpoints for disease diagnosis and health state assessment.

The recipient of this fellowship will have an opportunity to work on different projects both at the PfIRe Lab and as part of larger clinical trial teams at Pfizer. The fellows will get experience in translational medicine, clinical trial design, and drug development in preparation for a future role in industry or academic clinical research. The fellows will be required to commit 75% of their time to Pfizer ECD projects and 25% commitment to clinical activities at MGH within the department of Neurology or Psychiatry. The clinician-scientist are selected by a joint Pfizer-MGH search committee and employed by the Massachusetts General Hospital.

Drug development or computational experience including signal processing and machine learning is a plus, but not required. The program provides annual salary support plus benefits. The awardee may receive additional support for tuition, travel, and supplies. Appointment begins on July 1st, 2023.

MINIMUM ELIGIBILITY REQUIREMENTS

- Physician scientist who is or will be a BC/BE Neurologist or Psychiatrist by July 1, 2023.
- Current Fellow or Junior faculty in Neurology or Psychiatry
- Ability to commit 75% of time to Pfizer and 25% of time to MGH
- Application must be submitted by November 1, 2022 for consideration

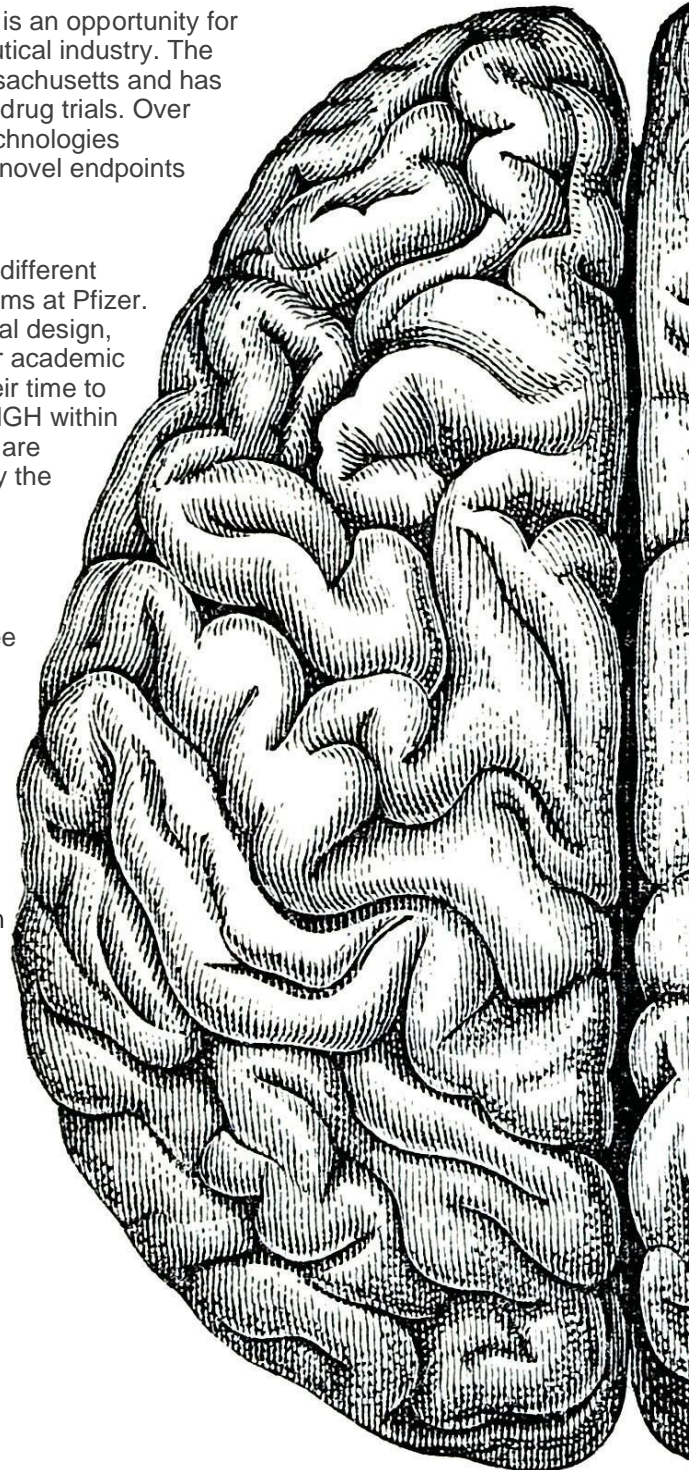
